I was extremely fortunate to serve as president during such an exciting year. We celebrated 25 years as the Nashua Pastoral Care Center with a gathering in January. We recognized the Agency and its many contributions to greater Nashua over the last quarter century. On the same night we announced our new name: The Front Door Agency! The new name, logo and tagline, "Your Path to Self Sufficiency" clearly identifies our mission. This rebranding was the result of an extensive strategic planning process that illustrates that while we celebrate the past, we are looking to the future.

It was a year of growth and recognition. The acquisition of the Shattuck Street property provided six units of permanent affordable housing. Thanks to the vision and tireless efforts of Maryse and her staff, The Front Door not only survived during tough economic times, but flourishes and grows. That management skill was recognized this year when The Front Door received the Corporate Fund Award for Excellence in Management, a very prestigious honor. Congratulations Maryse!

Another accomplishment this year was the creation of a succession plan for the Agency should Maryse win the lottery. It is a very detailed plan that will ensure the agency's continued functioning under any given scenario. It is just another indication of a well-managed agency.

I would like to take this opportunity to thank our five Corporate Partners for this year. Gold Partners are Cityside Management and Cirtronics. Silver Partners are BAE Systems and The Nashua Bank. Our Bronze Partner (new this year) is Triangle Credit Union. All are doing their part to help us achieve our mission of transitioning families to self-sufficiency.

Our current Board of Directors is engaged and active in fundraising activities. We are extremely lucky to have such a vital group of people with a passion for our mission. With the addition of new board members this past year, our Finance Committee has become stronger and implemented new reporting systems that have helped all board members to better understand the financial health of the agency and provide better forecasting for the future. With their continued stewardship, the Front Door will remain a solid enterprise for many years to come.

Lastly, I would like to recognize departing board members Lesley Bouvier, Deb Christiansen, Bob Hayes, and Amy Wheeler-Teas (who still holds the record for the most Gourmet raffle tickets sold) and thank them for their service. I would be remiss in not mentioning the passing of a former Board Member and President who was instrumental in creating our Endowment Program and securing our future for many years, Dr. Ronald Kraus, who lost his battle with cancer earlier this year. He will be greatly missed.

I look forward to 2013 and the continued successful outcomes of those individuals and families served by the Front Door Agency.

This past year has been one of excitement, growth, change, and sadness. I lost a great friend and mentor, Dr. Ronald Kraus. He served on our Board of Directors for nine years providing vision and leadership. He led the agency through a successful Endowment Campaign in 2004 and subsequently through its last strategic plan – both efforts having a positive impact on our financial stability. Ron's ability to gather people together for the common good of this community was inspiring. He is someone I admire, and I can only aspire to become half the person he was. His legacy will live on at the Front Door Agency.



Our celebration of 25 years of service to this community brought excitement and sadness as well. The Nashua Pastoral Care Center, Inc., meant a great deal to me as I have been involved with the agency for nearly 20 years. The decision to change our name was not taken lightly. With this said, I do believe it was time to make the change; and I love the direction our agency has taken with our new name, The Front Door Agency, your path to self-sufficiency.

This annual report illustrates how we have helped families transition from crisis to self-sufficiency . . . real people making real change. Even with the challenging economic times and decreases in funding, we have been able to maintain our current level of programming as well as expand our supportive services. After reviewing the needs of our constituents, it became evident that a comprehensive mental health program was needed. This past year we hired a Licensed Mental Health Counselor, Elizabeth Portash, to offer mental health services to the community, particularly those on Medicaid or who do not have insurance. It has also provided us the opportunity to assess our transitional housing clients prior to starting the program and develop case management plans to ensure their success.

Just prior to our year-end, we added a new component to our housing program with the purchase of a 6-unit affordable housing project known as Shattuck Place. We are very excited to add this to our housing portfolio, and we now offer a systematic housing program beginning with Phase 1, the Norwell Home congregate living, through Phase III, permanent affordable housing.

I am very proud of the staff, volunteers, and Board of Directors. It has been a privilege to work with our Board President, Cindy Woessner. It is because of their efforts and dedication that we earned the prestigious Walter Dunfey Excellence in Management Award from the Corporate Fund this past year. These individuals work tirelessly in ensuring the most vulnerable in our community receive the best possible services in the most cost efficient manner. They are true stewards of what we represent.

As I enter my 15th year as CEO of this vibrant organization, I am excited to continue the great work we do and build upon all the wonderful relationships we have established in the community.

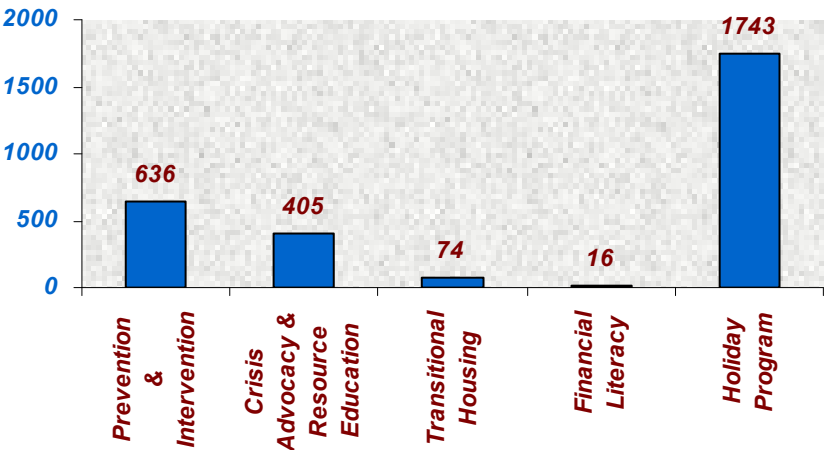
Prevention & Intervention of Homelessness

- Homelessness or utility disconnection was prevented for 365 individuals (102 families) equaling \$62,537 in assistance.
- Permanent housing was made available to 75 families (271 individuals) through our Security Deposit Loan Program (HSGP) and Revolving Loan Fund (HHARLF). This represents \$92,258 of assistance given out in the form of vouchers to landlords. Clients repay the loan to the Agency, and the landlord redeems the voucher for cash when the loan is paid in full.

Transitional Housing

- 27 homeless families (74 individuals) participated in this structured, 3-phased residential program during the year. All clients received the supportive services they needed, and all clients participated in some type of educational or job training program.
- Corin and Tara successfully graduated from the program last spring. Corin received her LPN from St. Joseph School of Nursing, and Tara received her Associates Degree from Nashua Community College.

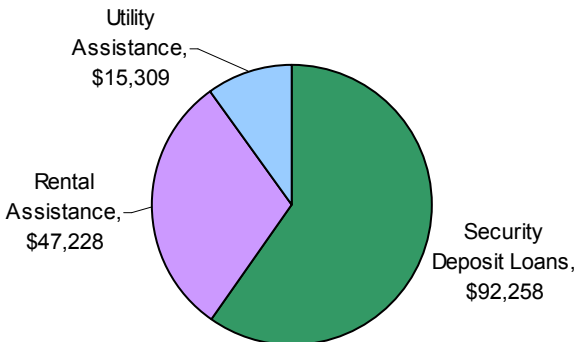
Crisis Advocacy & Resource Education

- 405 individuals recovering from a crisis received assistance with basic needs such as prescriptions, auto repair and registrations, food, gas for the car, bus tickets, and other miscellaneous items.
- The Holiday Program provided gifts and food for 512 families, which represents 1,067 individuals. The Telegraph Santa Fund is part of this Agency program.

Financial Literacy

- 16 individuals participated in this 5-week, free course on basic personal financial management. This is offered in partnership with the Family Resource Center of Greater Nashua, housed in the Boys and Girls Club.
- The curriculum was updated, revised, and improved during the spring, and plans were made to offer two sessions the following year. It is a goal to offer one session in Spanish as well.

The Agency received the prestigious Walter Dunfee Excellence in Management Award, which is a testament to the leadership and innovation that the Front Door has shown over its 25-year history.



Highlights from FY 2012:

- ♦ *Mental Health Counseling Program was launched*
- ♦ *Successful collaboration with Bridges, the domestic violence shelter in Nashua, on a grant proposal to support housing beyond the shelter for women fleeing domestic violence. This program is now in operation.*
- ♦ *Purchased a 6-unit apartment complex in Nashua that increased housing capacity to 26 units, allowing us to now offer permanent affordable housing.*
- ♦ *Increased the members of the Planned Giving "Legacy Society" to 11.*
- ♦ *Three Transitional Housing clients successfully graduated from the program.*

Agency purchases Norwell Home expanding its Transitional Housing Program by 80%. Phase I was created providing a group setting for 8 families—increasing housing capacity to 18 families.

2007

Agency celebrates 20 years of service, along with honoring The Rev. Dr. Robert Odierna's (Odie) 20 years of active service to the agency.

2012

The Nashua Pastoral Care Center becomes the Front Door Agency. Agency purchases a 6-unit complex on Shattuck Street increasing our housing capacity to 26 families. Mental Health Counseling was added as a core program.

A Future Secured . . . *Corin's Story*



"I woke up this morning, put on my scrubs to get ready to go to work at Dartmouth-Hitchcock, got my daughter ready for daycare, and left my own apartment looking forward to the day. So much has changed in my life.

Three years ago I woke up not knowing how I was going to make it through another day. My partner, my daughter's father, had become abusive; we were no longer safe; I had no money and no job; and we had no where to go. It couldn't have gotten any worse. We left and stayed with a few friends and relatives, but the stark reality was - we were homeless. I started to look

for places that might be able to help us, and ultimately was referred to the Front Door Agency's Transitional Housing Program by the Upper Room in Derry, NH. The day I was accepted into this program is the day my life began to transform. This is what happened. I was assigned a case manager who guided and supported me through the process of applying for TANF, childcare assistance, and food stamps. The other programs of the Front Door were able to provide the basics that I didn't have. She arranged for therapy sessions, and together we came up with a plan for what I thought I might like to pursue for a career and where I could apply for the appropriate education. I had an interest in the medical field, so I took a course at the American Red Cross and became a Certified Nurse's Assistant. I loved it! I knew I wanted to pursue nursing, so I applied to St. Joseph School of Nursing and was accepted. By this time I was in Phase II of the program, which meant I moved into one of the Front Door's apartments while still working very closely with my case manager. She told me about Good News Garage, and I was able to get a car donated to me, which helped tremendously. In May of 2012 I graduated with my LPN, passed my nursing boards in June, and got a job as a nurse at Dartmouth-Hitchcock in July. Words cannot describe how this program has made all the difference in my life and the life of my little girl, now 4 years old."

A Future Secured . . . Tara's Story

Tara and her daughter entered the Transitional Housing Program three years ago after leaving a domestic abuse situation. Tara learned about the Transitional Housing Program through a parent resource group at her daughter's school. After being accepted, they moved into the Norwell Home, Phase I, where they remained for almost a year. During that time they both benefitted from many supportive services provided through the Front Door's other programs—help with food and transportation, the Holiday Program, Financial Literacy, summer camp for her daughter, who was almost 10 when they entered the program. Tara enrolled at the Nashua Community College and began her studies in the field of Human Services. When the time was right, they moved into one of the apartments located on Vine Street, which is Phase II of the program. Here Tara and her daughter lived a little more independently, while still working closely with their case manager. At the same

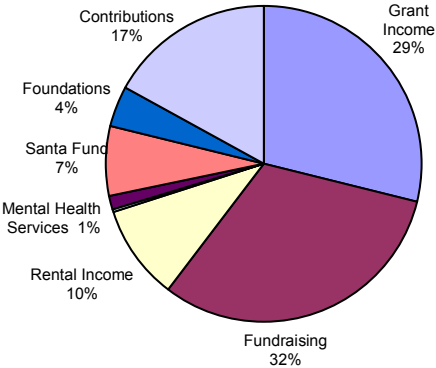
time that Tara graduated with her Associates Degree in Human Service from the Nashua Community College, she and her daughter moved into Phase III, the most recent expansion to the Transitional Housing Program, which had just become available. Phase III provides housing of a more permanent nature that is available to our Phase II graduates. Still living there today, Tara is now pursuing her bachelor's degree in Human Services at Springfield College and is scheduled to graduate next December. Tara's hard work and dedication to improving life for herself and her daughter embodies the essence of what our Transitional Housing Program was designed to accomplish. It is the path to self-sufficiency.

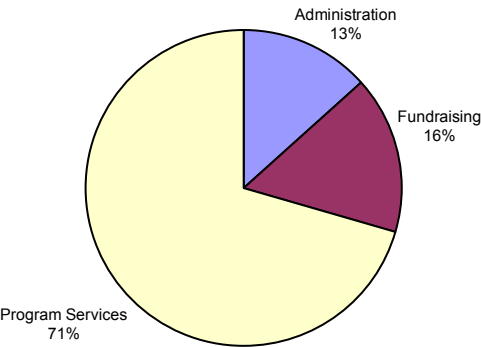

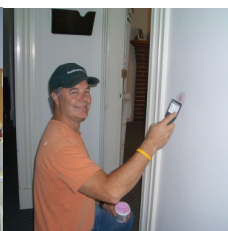
