The Front Door Agency's Legacy Society recognizes individuals and couples that plan to make future gifts through their estates to support the Agency's work. By making a legacy gift to the Front Door Agency, your generosity and foresight will transform the lives of families in our community for generations to come.

What does your legacy gift provide to families in need?

\$10,000

Ensures that three single mothers and their children have safe, affordable housing for a year while they pursue job training or higher education opportunities.

\$25,000

Provides housing stability services to ten families in need, including short-term rental assistance, utility assistance and case management.

\$50,000

Gives 21 families a year access to career counseling, job skills training, job recruitment and job retention.

\$100,000

Provides ongoing capital improvements to our five housing facilities including new heating systems, windows, insulation and appliances.

\$250,000

Gives 40 women and children affordable housing, case management, financial literacy training, access to therapy and academic scholarships.

\$500,000

Allows the Agency to expand our current affordable housing portfolio by an additional four to six units.

\$1,000,000

Provides ongoing, annual support for our critical programs and supports through investment growth.
